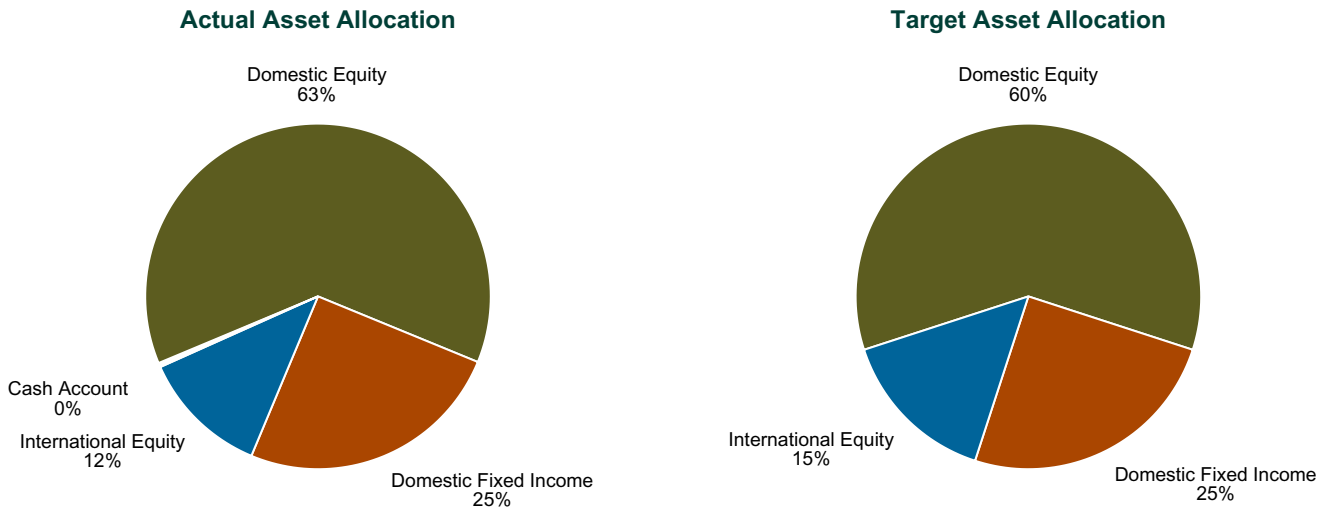


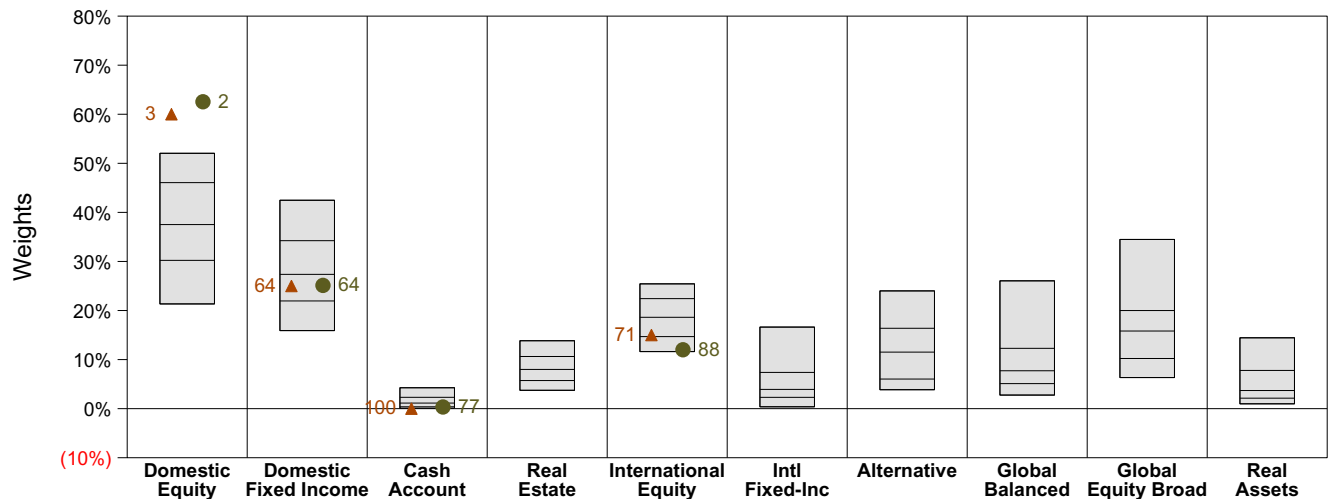
Actual vs Target Asset Allocation As of June 30, 2015
